### ~LAW ENFORCEMENT AWARD~

The Law Enforcement Award is given to a law enforcement officer(s) who has worked directly with CICP member(s) and/or CICP staff to aid in the prevention, recovery, arrest, or process of impacting theft and/or vandalism on construction jobsites.

### ~LAW ENFORCEMENT PARTNER AWARD~

The Law Enforcement Partner Award is given to an officer, a police department, a unit, or an agency that has been instrumental in creating partnerships between CICP members and law enforcement and promoting cooperation for the prevention of construction industry theft.

### ~PARTNERSHIP AWARD~

The Partnership Award is given to members, organizations, vendors, or agencies that have developed or contributed to a special event, activity, or project to promote the CICP program.
